| Please Note | <ul style="list-style-type: none"> ✓ Call at least 24 hours prior to the test if you cannot attend. If you do not, you will have to reregister and pay again. ✓ Registration fee can be transferred to another testing night, but it is NON-REFUNDABLE after June 30 of the fiscal year. |
| Prior to Testing | <ul style="list-style-type: none"> ✓ Make sure you have TWO forms of ID ✓ One must be a valid PA Driver's License or PA State Picture ID ✓ The second form can be: Social Security Card, Military ID (with SSN preprinted), Tax Form (with SSN preprinted), Payroll Stub (with SSN preprinted) <i>If you do not have these forms of ID, you will not be allowed to test.</i> |

From the North

- * Follow Route 100 south to business Route 30
- * Turn right onto Route 30 west
- * Follow Route 30 west to Quarry Road
- * Turn left onto Quarry Road
- * Follow for approximately 1/2 mile to the second traffic light (Boot Road)
- * Turn right onto Boot Road
- * Follow approximately 1/4 mile to 455 Boot Road (on the right after the Dopaco building)

From the South

- * Follow Route 100 north to the Route 30/100 intersection and turn left at light onto business Route 30 west
- * Follow Route 30 west to Quarry Road and turn left
- * Follow for approximately 1/2 mile to the second traffic light (Boot Road)
- * Turn right onto Boot Road
- * Follow Boot Road for approximately 1/4 mile to 455 Boot Road (on the right after the Dopaco building)

From the West

- * From Route 30 bypass, exit at business Route 30/Lancaster Avenue
- * At the traffic light at the bottom of the ramp turn left onto Quarry Road
- * Follow Quarry Road for approximately 1/4 mile to the first traffic light (Boot Road)
- * Turn right onto Boot Road
- * Follow for approximately 1/4 mile to 455 Boot Road (on the right after the Dopaco building)

From the East

- * From Route 202 south, exit at the US 202/30 interchange onto the Route 30 west bypass
- * Take the Route 30/Lancaster Avenue interchange exit to business Route 30 west
- * At the traffic light at the bottom of the ramp turn left onto Route 30 west
- * Follow business Route 30 west to Quarry Road and turn left
- * Follow Quarry Road for approximately 1/2 mile to the second traffic light (Boot Road)
- * Turn right onto Boot Road
- * Follow for approximately 1/4 mile to 455 Boot Road (on the right after the Dopaco building)
