

DELAWARE COUNTY COMMUNITY COLLEGE – ACTUAL VS INDEX

The Pennsylvania College and University Security Information Act mandates the release of crime statistics and rates to matriculated students and employees. The index rate is based on the standard formula for taking the number of offenses, multiplied by a population of 100,000 and divided by the total full-time enrollment (FTE). It's a statistical projection and standard rounding rules are applied. FTE for 2024 is reported as 5011.

2023: After a review of standards, internal Disorderly Conducts do not meet the legal criteria.

2025: After a review of the previously reported FTE numbers, inconsistencies were found. The Index numbers have been updated to reflect the changes. 2022=5200, 2023=4979.
